EV enters into an agreement to sell Or Brun to SBM company and thus focuses on the agricultural market.

Geneva/Paris, 6 December 2021 – ÉLÉPHANT VERT reports the signing of an agreement to divest its OR BRUN business to SBM Company. SBM Company has been a major player in the field of consumer gardening for more than 20 years with a mastery of the entire value chain from development to distribution. After consultation with the employee council (CSE), closing of the transaction is expected before year-end 2021.

The OR BRUN business was acquired by ÉLÉPHANT VERT in 2017 and has since grown significantly. The sales price reflects OR BRUN's strong positioning as a leading gardening brand in the French market, as well as the considerable progress it has made in recent years in rejuvenating its brand and positioning, benefitting from product innovations driven by the ÉLÉPHANT VERT group.

ÉLÉPHANT VERT is focusing its growth on innovative bio-intrants for the agricultural segment. The divestment of OR BRUN allows the group to intensify and accelerate its investments in the areas of bio-stimulants and bio-controls. With today's divestment announcement, a first step of the strategic portfolio adjustment has been completed. ÉLÉPHANT VERT plans some strategic acquisitions in the near future.
